

EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this 19th day of May, 1975, by and between CROWN ZELLERBACH CORPORATION, a Nevada corporation, herein called "Crown," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, wherein called "State," WITNESSETH:

Whereas, on the 24th day of August, 1972, Crown and the State entered into an easement exchange hereinafter called Original Agreement, which was recorded in the records of Skamania County, Washington, on the 8th day of November, 1972, in Volume 64 of Deeds, pages 677 through 686 under Auditor's File No. 75490.

I

Crown for and in consideration of Two Hundred and Twenty-Five Dollars (\$225.00) hereby grants and conveys to State, its successors and assigns, a permanent easement assignable in whole or in part upon, over, and along right of way sixty (60) feet in width, over and across the S½SE¼ of Section 14, Township 3 North, Range 7 East W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline(s) of a road or roads located approximately as shown in red on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

Except as herein supplemented all of the terms, conditions and reservations of the Original Agreement shall remain in full force and effect.

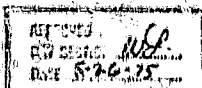
