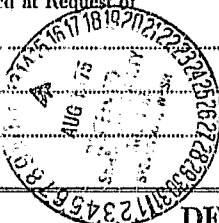

GRANTOR(S) Lyle W. Ternahan and Elena M. Ternahan, husband & wife 80635

for and in consideration of the sum of One Dollar and other valuable considerations
 (\$ 1.00) Dollars, to us in hand paid, and in further consideration of the general public
 welfare, do by these presents grant, convey and dedicate to SKAMANIA County,
 State of Washington, for the use of the public as a county road and appurtenances the following de-
 scribed real property in the County of SKAMANIA State of Washington:

A right of way for the County Road known and designated as the Cook Underwood Road
 (County Road No. 93041) located in Section 20, Township 3 North, Range 10 E.W.M.,
 Skamania County, Washington, more particularly described as follows:

Commencing at the intersection of the Cook Underwood and Kollock Knapp County Road;
 thence East along the centerline of the Cook Underwood County Road as described in the
 survey of Old State Road No. 8 now on file in the Office of the Skamania County Engineer
 490 feet more or less to the extension of the West property line of John M. Ostenson as
 described in Deed Book 67, Page 750 on file in the Office of the Skamania County Auditor.
 Thence North along the West property line extension 40 feet; thence West parallel to
 and 40 feet northerly of the afore described centerline of the Cook Underwood Road 490
 feet more or less to the East right of way line of the Kollock Knapp County Road; thence
 South along this right of way line to the centerline of the Cook Underwood Road and the
 point of beginning.

Said parcel containing 0.45 acres more or less.

County and its successor or successors for the use of the public forever.
