DEDICATION DEED 80636

GRANTOR(S) Leo A. Terhorst and Patricia A. Terhorst, husband & wife

for and in consideration of the sum of One dollar and other valuable considerations

(\$ 1.00) Dollars, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to SKAMANIA County, State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of SKAMANIA, State of Washington:

A right of way for the County Road known and designated as the Marrian Didier Road (County Road No. 11250) located in Section 6 and 7, Township 1 North, Range 5 E.W.M. in Skamania County, Washington, more particularly described as follows:

RIGHT OF WAY DESCRIPTION

A strip of land 40 feet in width lying easterly of and contiguous to the following described centerline from approximate Station 1 + 50. to Station 7 + 10.02 in the South half of the Southwest One Quarter of Section 6, Township 1 North, Range 5 E.W.M. Also a strip of land 40 feet in width lying easterly of and contiguous to the following described centerline from Station 7 + 10.02 to approximate Station 12 + 33 in the North half of the Northwest One Quarter of the Northwest One Quarter of Section 7, Township 1 North, Range 5 E.W.M.

CENTERLINE DESCRIPTION

Commencing at a point 612.362 feet North and 1330.591 feet East, of the Southwest Corner of Section 6, Township 1 North, Range 5 E.W.M.; said point being at the intersection of Marrian Didier and Bell J. C. County Road centerline; thence following Marrian Didier Road centerline S 14° 35' 08" W 50.449 ft., to the P.C. of a 300 foot radius curve to the right; thence following said curve 196.32 ft. to P.T. Sta. 2 + 45.81; thence S 52° 4' 45" W 2.26 feet to the P.C. of a 200 foot radius curve to the left; thence following said curve 133.05 feet to P.T. Station 3 + 82.12; thence S 21° 35' 11" W 37.76 feet to the P.C. of a 200 foot radius curve to the left; thence following said curve 50.31 feet to P.T. Station 4 + 70.19; thence S 7° 10' 25" W 57.52 feet to the P.C. of a 200 foot radius curve to the right; thence following said curve 103.62 feet to P.T. Sta. 6 + 31.33; thence following said curve 95.24 feet to P.T. Sta. 7 + 69.93; thence S 12° 44' 52" E 84.72 feet to the P.C. of a 60 foot radius curve to the right; thence following said curve 71.26 feet to P.T. Sta. 9 + 25.91; thence S 55° 17' 55" W 40.98 feet to the P.C. of a 175 foot radius curve to the left; thence following said curve 117.57 feet to P.T. Sta. 10 + 84.46; thence S 16° 48' 19" W 25.29 feet to the P.C. of a 510 foot radius curve to the right; thence following said curve 102.57 feet to P.T. Sta. 12 + 12.32; thence S 28° 19' 43" W 0.88 feet to the P.C. of a 2000 foot radius curve to the left; thence following said curve 80.68 feet to P.T. Station 12 + 93.88, end of project, said point lying 1130.452 feet North and 507.639 feet east of the Southwest corner of Section 7, Township 1 North, Range 5 E.W.M. in Skamania County, Washington.

Consisting of a total of 1.0 acres less existing rights of way for a net acreage of .52 acres more or less.


