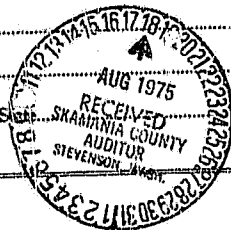

GRANTOR(S) Roy C. Louthier and Leatha Louthier, husband and wifefor and in consideration of the sum of One Dollar and other valuable consideration(\$ 1.00)Doors, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to SKAMANIA County,State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of SKAMANIA, State of Washington:

A right of way for the County Road known and designated Louthier Road (County Road No. 23410) located in the Northeast One Quarter of the Southwest One Quarter of the Southeast One Quarter (NE 1/4 SW 1/4 SE 1/4) of Section 36, Township 4 North, Range 7 1/2 East W.M. in Skamania County, Washington.

More Particularly:

A right of way 40 feet in width, lying 20 feet right and 20 feet left of the centerline of Louthier Road as existing in 1975: Commencing at the South line of the Northeast One Quarter of the Southwest One Quarter of the Southeast One Quarter (NE 1/4 SW 1/4 SE 1/4) of Section 36; thence running 600 feet more or less in a Northwesterly direction.

Containing 0.55 acres more or less.

TO HAVE AND TO HOLD the said described premises unto the said SKAMANIA County and its successor or successors for the use of the public forever.

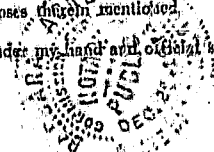
