I, the undersigned, being the owner of the property herein described, do, in consideration of the benefits and advantages to accrue to me by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as examined and surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way variable feet in width over and across the following described piece or parcel of land, to-wit:


A strip of land adjacent to and South of the Newquist Road Right of Way, located to the West of the Robert Nordall driveway. Said strip of land being 30 feet in width extending South from the right of way and 75 feet in length extending to the West from the driveway.

and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a County Road.

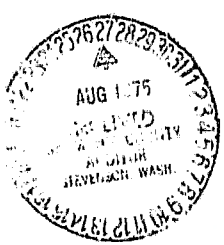
