KNOW ALL MEN BY THESE PRESENTS: That this agreement made and entered into this 21 day of March, 1962, by and between JOHN H. BOSSHART, JR. and DOROTHY G. BOSSHART, husband and wife, residing in Pierce County, State of Washington.

WITNESSETH, that whereas the said parties hereto are owners of certain separate and community property, and are desirous that said property, together with all other separate and community property, either real or personal, that may hereafter be acquired, shall pass, without delay or expense, upon the death of either, to the survivor, and that all property of either spouse shall be considered community property,

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00), the receipt of which is hereby acknowledged by each party hereto, and, also, in consideration of the love and affection that each of said parties bears for the other, it is hereby agreed that in the event of the death of said JOHN H. BOSSHART, JR. while said DOROTHY G. BOSSHART survives, then the whole of said separate and community property now owned, together with all other separate and community property, real or personal, that may hereafter be acquired, shall at once vest in said DOROTHY G. BOSSHART in fee simple; and in the event of the death of said DOROTHY G. BOSSHART while the said JOHN H. BOSSHART, JR., survives, then the whole of said separate and community property now owned, together with all other separate and community property, real, and personal, that may hereafter be acquired, shall at once vest in said JOHN H. BOSSHART, JR. in fee simple.
