Subject only to the following rights outstanding in third parties, namely:

Existing easements for public roads and highways, public utilities, railroads and pipelines, and

Reservations contained in patents from the United States of America.

Excepting and Reserving to the Vendor the right to remove an 8'4" x 12' shed and approximately 100 linear feet of wood fencing on or before 1 July 1976.
