THE GRANTOR GAIL G and CAROL J. COLLINS, husband and wife

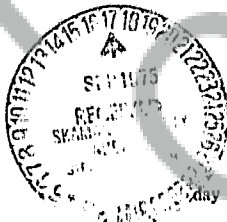
for and in consideration of Ten Thousand Dollars (\$10,000.00)
