DEDICATION DEED

GRANTOR(S) Geneva McNicholl

for and in consideration of the sum of One Dollar and other valuable considerations
 (\$ 1.00) Dollars, to us in hand paid, and in further consideration of the general public
 welfare, do by these presents grant, convey and dedicate to SKAMANIA County,
 State of Washington, for the use of the public as a county road and appurtenances the following de-
 scribed real property in the County of SKAMANIA, State of Washington:

A right of way for the County Road known and designated as the Cook-Underwood Road
 (County Road No. 93041) located in Section 14, Township 3 North, Range 9 E.W.M. in Skamania
 County, Washington, more particularly described as follows:

Commencing at the Southwest corner of Lot 1 of the Oregon Lumber Company plat as recorded
 in page 29 of the Official Plat Book of the Auditor of Skamania County; thence East along the
 South line of Lot 1 for 400 feet more or less (this portion being 30 feet in width, the most
 northerly 10 feet of said 30 feet to be used for pedestrian facilities and to be maintained
 in as near natural state as is possible); thence on a curve to the left 300 feet more or
 less (this portion being 60 feet in width, the westerly 10 feet of the easterly 10 feet to
 be used for pedestrian facilities and to be maintained in as near natural state as is possible);
 thence continuing on the curve to the left 150 feet more or less; thence on a curve to the
 right 300 feet more or less (this portion being 60 feet in width); thence continuing on the
 curve to the right to the intersection with the W&S line of said Lot 1, (this portion being
 90 feet in width). All the above described right of way centered on the Cook-Underwood Road
 Centerline as now constructed and existing.

Said parcel containing 1.54 acres more or less.

TO HAVE AND TO HOLD the said described premises unto the said SKAMANIA
 County and its successor or successors for the use of the public forever.
