In case any part of said real estate is taken for public use, the portion of the condemnation award remaining after payatent of reasonable expresse of procuring the same that be paid to be seller and applied as payment on the purchase price berein unless the seller elects to uflow the purchaser to apply all or a portion of such condemnation award to the rebuilding or restoration of improvements damaged by such twing. In case of stanged or destruction from a peril insured against, the proceeds of such improvements within a reasonable capeage of procuring the same shall be devoted to the restoration or rebuilding of such improvements within a reasonable clust, unless purchaser elects that said proceeds shall be paid to the seller for application on the nurchase neighbor herein. chase price herein.
