The escrew collection account should be set up at the Washington State Bank in Camas, Washington and they will hold the fulfillment deed which will be a warranty deed, until the entire amount is paid, at which time it will be given to the Purchasers above named.

The balance of Eight Thousand Dollars shall be payable at \$100.00 or more per month, with the first payment to commence on November 1, 1975, and a like payment to be due and payable on the first day of each following month uncil the entire amount is paid. Interest shall be charged at the rate of 8 1/2 percent simple interest annually, which amount will be added to the amount of the purchase price.

The 1975 taxes will be paid and totalled by the Sellers, but that Furchaser will contribute \$25.00 towards the taxes for 1975 and that henceforth the Purchasers will be responsible for the taxes.

As referred to in this contract, "date of closing" shall be October 1, 1975.

(1) The purchaser assumes and agrees to pay defore delinquency all taxes and assessments that may as between granter and granter betreatter become a lien on said real estate; and if by the terms of this contract the purchaser has assumed payment of any mostgage, contract or other encumbrance, or has assumed payment of or agreed to purchase subject to, any taxes or assessments now a lien on said real estate, the purchaser agrees to pay the same before delinquency.
