

RIGHT OF WAY CONTRACT AND EASMENT

For and in consideration of the sum of Fifty Dollars (\$50.00) and other good and valuable consideration, Melvin L. Evans and Dorothy L. Evans, husband and wife, of Stevenson, Washington, hereinafter referred to as Grantors, do hereby grant and convey to Columbia Gas Company, A Washington Corporation, its successors and assigns, hereinafter referred to as Grantee, the right to construct, maintain, inspect, operate, protect, repair, replace, alter or remove a pipeline for the transportation of natural gas, on over and through the following described land, to-wit: Within 20 feet of West Line of that portion of Lot 5 and all of Lot 6, of Block 6, Section 36, Township 31, Range 7 E., Johnson's Addition to the Town of Stevenson, Shoshone County, Washington, owned by the above named Grantors, together with the right of ingress and egress to and from said line for the purposes aforesaid.

Grantee shall properly backfill any ditch used in the construction and/or repair of said gas line, and shall restore the surface as nearly as may be possible to its original condition.

Grantors shall have the right to use and enjoy the above described premises except as the rights herein granted.

Grantee shall have the right to assign this grant in whole or in part.

The terms, conditions and provisions of this agreement shall extend to and be binding upon the heirs, executors, administrators, personal representatives, successors and assigns of the parties hereto.

In the event that the Grantors or their successors desire to enter in to construction upon the premises above described, and the gas

line hereinabove mentioned interferes in any way with such construction  
the expense of relocating and moving pipeline shall be borne by the  
Grantee.

TO HAVE AND TO HOLD said Right of Way and Basement unto said  
Grantee, its successors and assigns until the pipeline be constructed  
and so long thereafter as a pipeline is maintained thereon.


