in hand paid, conveys and warrants to GLEN F. MASON and Thelma A. Mason, his wife

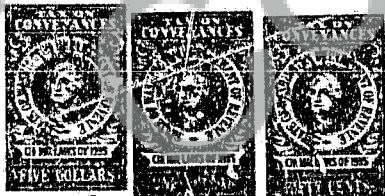
the following described real estate, situated in the County of Skamania, State of Washington:
