REAL ESTATE CONTRACT

THIS CONTRACT, made and entered into this 1Jth day of January, 1976.

between HENRY J. TOEWS and MARGARETHA TOEWS, husband and wife,

hereinafter called the "seller," and NORMAN C. OLSON and CAROL L. OLSON, husband and wife,

hereinafti called the "nurchneer"

WITNESSETII: That the seller agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in Skamania County, State of Washington:

Lot 12 of Block One of WOODARD MARINA ESTATES according to the official plat thereof on file and of re_ord at pages 114 and 115 of Book A of Plats, Records of Skamania County, Washington;

TOGETHER WITH shorelands of the second class conveyed by the State of Washington, fronting and abutting upon the above described real property.

The terms and conditions of this contract are as follows: The purchase piece is THIRTY WE THOUSAND FIVE HUNDRED and NO/100 (\$ 32,500.00 - (\$6,500.00) Dullars, of saich SIX THOUSAND FIVE HUNDRED and NO/100 -) Dollars have been paid, the receipt whereof is hereby acknowledged, and the balance of said purchase price shall be paid as follows:

The purchasers agree to pay the bulance of the purchase price in the sum of Twenty-six Thousand and No/100 (\$26,000.00) Dollars in monthly installments of Two Hundred and No/100 (\$200.00) Dollars, or more, commencing on the first day of April, 1976, and on the first day of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The said monthly installments shall include interest from March 1, 1976, at the rate of seven percent (7%) per annum computed upon the monthly balances of the unpaid purchase price, and the right at any time they are not in default under the terms and conditions of this contract to pay without penalty any part or all of the unpaid purchase price plus interest then due,

It is understood that the dwelling house on said premises is occupied by Mildred M. 0 Donnell under a lesse; in the event that Mrs. 0 Donnell retains possession after March 1, 1976, the monthly rent thereafter shall be paid to the purchasers.

4905 East Kerckhoff, Fresno, California All payments to be made hereunder shall be made at or at such other place as the seller may direct in writing. As referred to in this contract "date of closing" shall be March 1, 1976.

- (1) The purchaser assumes and agrees to pay before definition of the terms of this contract the purchaser has assumed pays. In any mortgage, contract or other encumbrance, or has assumed pays at of or agreed to purchase subject to, any taxes or assessments now relief on said real estate; the purchaser agrees to pay the same before delinquency.
- (2) The purchaser agrees, until the purchase price is fully paid, to keep the buildings now and hereafter placed of said real estate insured to the actual cash value thereof against loss or damage by both fire and windstorm in a company acceptable to the seller and for the seller's benefit, as his interest may appear, and to pay all premiums therefor and to deliver all policies and renewals thereof to
- (3) The purenast engrees that full inspection of said real estate has been made and that neither the seller nor his assigns shall be held to any covenant expecting the condition of any improvements thereon nor shall the purchaser or seller or the assigns of either be held to any covenant or agreement for alterations, improvements or repairs unless the covenant or agreement realied on is contained herein or is in writing and attached to and made a part of this contract.

 (4) The purchaser assumes all bazards of damage to or destruction of any improvements now on said real estate or hereafter placed thereon, and of the taking of said real estate or any part thereof for public use; and agrees that no such damage, destruction or taking shall remaining after payment of reasonable expenses of proturing the same shall be raid to the seller and applied as payment on the purchase therein thicks the seller clocks to allow the purchaser to apply all or a portion of such condemnation award to the rebuilding or restoration of any improvements damaged by such taking, in case of damage or destruction from a peril insured against, the proceeds of such improvements within a reasonable expense of proturing the same shall be deviced to the restoration or rebuilding of such purchase price herein.
- (5) The seller has delivered, or agrees to deliver within 13 days of the tate of closing, a purchaser's policy of title insurance in standard form, or a commitment therefor, issued by Fronsemprica Title insurance Company, insuring the purchaser to the full amount of said purchase price against loss or damage by reason of defect in seller's title to said real estate as of the date of closify and containing no exceptions other than the following:
 - a. Printed general exceptions appearing in said policy form;
 - b. Liens of encumbrances which by the terms of this contract the purchaser is to assume, or as to which the conveyance hereunder is to be made subject; and
 - e. Any existing contract or contracts, under which seller is purchasing said real estate, and any mortgage or other obligation, which seller by this contract agrees to pay, none of which for the purpose of this paragraph (5) shall be deemed defects in seller's title.

(6) If seller's title to said mal estate is subject to an existing fontract or contracts under which seller is purchasing said real estate, or any mortgage or other obligation, which seller is to pay, selk, agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser shall have the right to make any pay tends recessary to remove the default, and any payments so made shall be applied to the payments next falling due the seller under this contract.

(7) The seller agrees, upon receiving full payment of the purchase price and interest in the manner above specified, to execute and deed to said real estate, excepting any part thereof hereafter deliver to purchaser a statutory warranty taken for public use, free of encumbrances except any that may attach after date of closing through any person other than the seller, and subject to the following:

- (a) General taxes for 1976 which shall be pro-rated between theparties as of March 1, 1976; and
- (b) Restrictive covenants and electric power line easement to Skamania County Public Utility District No. 1.
- (8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said real entate on date of closing and to retain possession so long as starchaser is not in default hereunder. The purchaser covenants to keep the buildings and other improvements on said real estate in good sepair and not to is milk waste and not to use, or exemit the use of, the real estate for any illegal purpose. The purchaser covenants to ray all services insulation or construction charges for water, sewer, electricity, garbage or other utility services turnished to said real estate after the date purchaser is enfitted to possession.

(9) In case the purchaser fails to make any payment herein povoided or to maintain insurance, as herein required, the seller may make such payment or effect such insurance, and any amounts so paid by the seller, together with interest at the rate of 10° per annum thereon from date of payment until repaid, shall be repayable by purchaser on seller's denand, all without prejudice to any other right the seller might have by reason of such default.

(10) Time is of the essence of this contract, and it is agreed that in case the purchaser shall fail to comply with or perform any condition or agreement hereof or to make any payment required hereunder promptly at the time and in the manner herein required, the seller may elect to declare all the purchaser's rights hereunder terminated, and upon his doing so, all payments made by the purchaser have right to re-enter and all improvements placed upon the real eviate shall be forefuled to the seller as highlated damages, and the seller shall be construed as a waiver of any subsequent default.

Service upon purchaser of all demands, notice, or other papers with respect to forfeiture and ermination of purchaser's rights may be made by United States Mall, postange pre-paid, return receipt requested, directed to the purchaser at his address hat known to the seller.

(11) Upon seller's election to bring suit to enforce any covenant of this contract, including suit to collect any payment required hereunder, the purchaser agrees to pay a reasonable sum as attorney's fees and all costs and expenses in connection with such suit, which sums shall be luchded in any judgment or decree entered in such sait.

If the seller shall bring suit to procure an adjudication of the termination of the purchaser's rights hereunder, and judgment is so entered, the purchaser agrees to pay a reasonable sum as attorney's fees and all costs and expenses in connection with such suit, which the purchaser agrees to pay a reasonable sum as atterney's fees and all costs and expenses in connection with such suit, and also the reasonable cost of scarching records to determine the condition of tibe at the date such suit is commenced, which sums shall be included in any judgment or decree entered in such suit.
