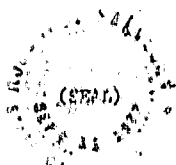

A tract of land situated in Section 21, Township 2 North, Range 7 East of the Willamette Meridian, Skamania County, Washington, being more particularly described as follows:

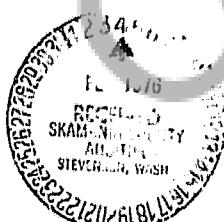

Also, reserving to the Vendor, in possession of the property, that portion of a building located on said described tract presently used for residential purposes only, in consideration of the protection and maintenance of the land, to which the Vendor hereby agrees, reserves the right to occupy until 4 August 1976 that portion of the lands herein described upon which said building and improvement are now situated. Such occupancy is subject to revocation by the District Engineer, Portland District, or his authorized representative, at anytime upon giving 90 days' notice in writing to the occupant if possession of the property is required by the United States prior to the expiration of the occupancy date above set forth.
