 Lot 4 of Section 8, Township 3 North, Range 8 E. N.W.M.; thence south
 following the east line of the said Lot 4 a distance of 475 feet;
 thence west 1300 feet more or less to intersection with the east
 line of the said Section 1; thence north 475 feet more or less to the

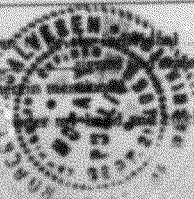

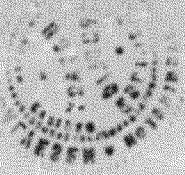

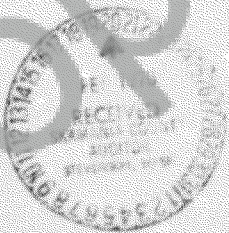
