the following described real estate, situated in the County of Skamania, State of Washington:

A parcel of property in Section 27, Township 3 North, Range 8 E. W. M., described as follows: Beginning at a point 1660.75 feet south and 1821.20 feet west of the northeast corner of the said Section 27, said point being in conformity with a survey by Olson Engineering dated November, 1975; thence south 17° 33' 30" west 393.44 feet; thence south 52° 43' 40" east 196 feet, more or less, to the centerline of Kelly-Henke Road; thence northwesterly along said centerline 450 feet, more or less, to a point that bears south 67° 15' 51" east from the point of beginning; thence north 67° 15' 51" west 164 feet, more or less, to the point of beginning; said tract containing two acres, more or less;
