FIRST SUPPLEMENT

Easement for road right of way under Application Nos. 2368 and F-5081
 granted in accordance with the authority of the Commissioner of Public Lands,
 dated the 3rd day of November, 1960, hereinafter referred to as the Original
 Easements, are hereby amended, modified and altered in the following particulars:

Beginning on the date herein subscribed, the road as described in the
 Original Easements shall be modified as shown on the plats marked Supplement 2368
 and Supplement F-5081, filed in the office of the Commissioner of Public Lands at
 Olympia, Washington, reductions of which are attached as Exhibits A and B,
 respectively, indicating said right of way in red and by this reference made a
 part hereof, all in Skamania County, Washington.

The road right of way designated hereinabove is subject to those terms
 and conditions of the Original Easements which are not inconsistent to the
 following:

The State reserves to itself all timber now on or hereafter growing
 within the rights of way on its said lands.

It is understood and agreed that those portions of the road described
 in the Original Easements which are abandoned as a result of the rights granted
 herein shall be immediately restored to a natural condition as may be directed
 by the State.

Except as herein expressly supplemented and modified, the Original
 Easements shall be and remain in full force and effect.




