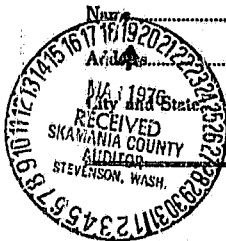

DEDICATION DEED

81891

GRANTOR(S) Edward C. Erickson and Belle Erickson, husband & wife

for and in consideration of the sum of Ten Dollars and other valuable considerations
(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public
welfare, do by these presents grant, convey and dedicate to SKAMANIA County,
State of Washington, for the use of the public as a county road and appurtenances the following de-
scribed real property in the County of SKAMANIA, State of Washington:

A right of way for the County Road known as the Wind Mountain Road in the Southeast one quarter of the Southwest one quarter of Section 26, Township 3 North, Range 8 E.W.M., 50 feet on the left and 30 feet on the right of the following described center line from Station 3 + 21 to Station 5 + 51.15 and 30 feet on each side of the following described centerline from Station 5 + 51.15 to Station 9 + 83. Beginning at a point 935 feet more or less West of the South Quarter corner of said Section 26, said point being P.O.C. Station 3 + 21 on a 35° curve to the left; thence along said curve 104.43 feet; thence N 6° 19' W, 125.72 feet to P.C. of a 8° 00' curve to the right; thence along said curve 310.83 feet; thence N 18° 33' E 121.02 feet more or less to North line of tract, excepting existing right of way.

Right of way described herein contains 0.94 acres more or less, and this dedication is meant to supersede the Waiver signed by Edward C. Erickson and Belle Erickson signed on the 17th day of March, 1965 and on Record in the Office of the Engineer, Skamania County.

TO HAVE AND TO HOLD the said described premises unto the said SKAMANIA

County and its successor or successors for the use of the public forever.
