REAL ESTATE CONTRACT

THIS CONTRACT, made and entered into this

hereinafter called the "purchaser,"

WITNESSETH: That the seller agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in Skamarria County, State of Washington:

The purchasers agree to pay the balance of the purchase price in the sum of Thirtyone Thousand Five Hundred and No/100 (\$31,500.00) Dollars in wonthly installments of Thousand Five Hundred Sixty-Four and 40/100 (\$264.40) Dollars, or more, commencing on the 1st day of Hay , 1976, and on the 1st day of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The said monthly installments shall include interest at the rate of nine percent (9%) per annum computed upon the monthly balances of the unpaid purchase price, and shall be applied first to interest and then to principal. The purchasers reserve the right at any time they are not in default under the terms and conditions of this contract to pay without penalty any aprt or all of the unpaid purchase price, plus interest

All payments to be made hereunder shall be made at Route 1, Box 35, Stevenson, Washington, 98648 or at such other place as the seller may direct in writing. As referred to in this contract, "date of closing" shall be.___ April 1, 1976

(3) The pure laster actumins all hazards of damage to or destruction of any improvements now on said real estate or hereafter placed thereon, and of the taking of said real estate or nay part thereof for purish use; and agrees that no such damage, destruction or taking shall remaining after payment of reatonable expenses of procuring in the same shall be paid to be seller and applied as payment on the furchase price herein unless the seller efects to allow the purchaser to apply all or a portion of such condemnation award to the rebuilding in restoration of any improvements damaged by such taking. In case of damage or destruction from a peril insured against, the proceeds of such improvements within a retsonable time, unless purchaser elects that said proceeds shall be paid to the seller for application on the purchase pirce herein.

- (8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said real estate on date of dosing and to retain possession so long as purchaser is not in default hereunder. The purchaser covenants to keep the buildings and other improvements on said real estate in good repair and not to permit waste and not to use, or permit the use of, the real estate for any illegal purpose. The purchaser covenants to pay all service, installation or construction charges for water, sever, electricity, garbage or other utility services furnished to said real estate after the date purchaser is entitled to possession.
