

## COMMUNITY PROPERTY AGREEMENT

This Community Property Agreement entered into this date by and between VIRGIL H. SAMPSON, JR. and LINDOL L. SAMPSON, husband and wife, both of Carson, County of Skamania, State of Washington:

## W I T N E S S E T H:

WHEREAS, the parties hereto are the owners of certain real and personal property situate in the State of Washington; and

WHEREAS, it is contemplated by the parties hereto that they may acquire additional property in the future; and

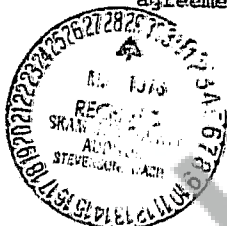
WHEREAS, it is the desire hereto that all of their property shall pass to the survivor without delay or expense in the event of the death of either party;

NOW, THEREFORE, we, VIRGIL H. SAMPSON, JR. and LINDOL L. SAMPSON, for and in consideration of the love and affection which we have one for the other, do hereby mutually agree that all of the property which we now own separately, jointly or otherwise, and whether real, personal or otherwise, and wheresoever situate, shall be and it is hereby declared to be the community property of the parties, and each of the parties to this agreement does hereby convey and transfer to the other party and to the community, all property owned by them, even though the same be held in his or her separate estate; and

We hereby mutually agree that all of the property which shall hereafter be acquired by either of us, whether separately, jointly or otherwise, and of whatsoever nature and wheresoever situate, shall be and it is hereby declared to be community property, and each of the parties does hereby convey and transfer to the other and to the community all such property hereafter acquired by either of them, even though the same be acquired in his or her separate estate, and

IT IS FURTHER AGREED that the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once, in the event of VIRGIL H. SAMPSON, JR. while the said LINDOL L. SAMPSON survives, be vested in LINDOL L. SAMPSON absolutely and in fee simple as her sole and separate property; and in the event of the death of the said LINDOL L. SAMPSON while the said VIRGIL H. SAMPSON, JR. survives, then the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once vest in the said VIRGIL H. SAMPSON, JR. absolutely and in fee simple as his sole and separate property.

IN WITNESS WHEREOF the parties have executed this agreement this 29th day of March, 1976.



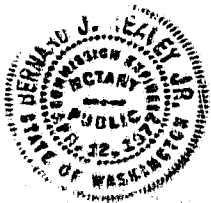
