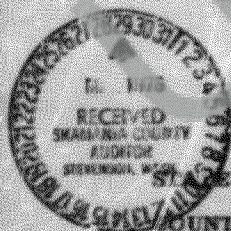
## QUIT CLAIM DEED

The Grantors, MIKE M. McKINZIE and ROSELE J. McKINZIE, husband and wife, for and in consideration of Ten Dollars (\$10.00) convey and quit claim to ROGER MALFAIT and LORETTA MALFAIT, husband and wife, the following described real estate, situated in the County of Shastana, State of Washington, including any interest therein which Grantors may hereafter acquire:

That portion of the East half of the North half of the Southeast quarter of Section Four (4), Township One (1) North, Range Five (5) East of the Willamette Meridian, described as follows: BEG. NING at the Northwest corner of the above described tract; thence East 320 feet along the North line of said tract to the true point of beginning; thence East 190 feet along the North line of said tract; thence South along a line parallel to the East line of said tract to the middle of Canyon Creek; thence South westerly along the middle line of Canyon Creek to a point 320 feet East of the West line of the above described tract; being the Southeast corner of that tract being sold to Garland B. Mabe by Real Estate Contract; thence North to the true point of beginning. Except County Roads.

This deed is given in lieu of a judicial declaration of forfeiture and cancellation of a Real Estate Contract executed April 10, 1958 between James H. Kaldenberg and Stella L. Kaldenberg as sellers and Michael Martin McKinzie and Jeanne Ronell McKinzie as buyers, the sellers' interest in which was assigned to the Grantees.

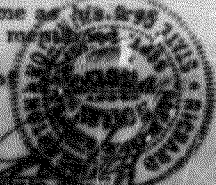
