REAL ESTATE CONTRACT

WITNESSETH: That the seller agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in County, State of Washington: Skamania

The North one-half of the Southeast one-quarter of Section Six (6) Township One (1) North, Range Five (5) East of the Williamette Meridian; EXCEPT, that portion thereof platted as Silver Star Acres according to the clat thereof platted, on file and recorded at page 153 of Book A of plats, records of Skamania County, Washington.

The terms and conditions of this contract are as follows: The purchase price is) Dollars, of which (\$ 20,000,00) Dollars have - (\$ 2,500.00) been paid, the receipt wiseres, in nerchy acknowledged, and the balance of said purchase price shall be paid as follows:

As referred to in this contract, "date of closing" shall be May 1, 1976

(1) The purchaser assumes and agrees to pay before del'inquincy all taxes and assessments that may as between grantor and grantee hereafter become a lien on said real estate; and if by the terms of this contral the purchaser has assumed payment of any mortgage, contract or other encumbrance, or has assumed payment of or agreed to purchase subject to, any taxes or assessments now a lich on said real estate, the purchaser agrees, until the purchase price is fully paid, to keep the huddings KMCCHOCKHOCKHORE and on said real estate insured to the actual cash value thereof against loss or damage hy both fire and windstorm in a company acceptable to the seller and for the seller's benefit, as his interest may appear, and to pay all premiums therefor and to deliver all policies and renewals thereof to the seller.

(3) The purchaser agrees that full inspection of said real estate has been made and that neither the seller nor his assigns shall be held to any covenant respecting the condition of any improvements thereon nor shall the purchaser or seller or the assigns of either be held to any covenant or agreement for alterations, improvements or regain unless the covenant or agreement for sin writing and attached to and made a part of this contract. Availability of water has not been represented.

(4) The purchaser assumes all hazards of damage to or destruction of any improvements now on said real estate or hereafter places thereon, and of the taking of said real estate or any part thereof for public use, and agrees that no such damage, destruction or taking shall constitute a failure of consideration. In case any part of said real estate is taken for public use, the portion of the consideration award for remaining after payment of reasonable expenses of procuring the same thall be paid to the seller and applied as properties of any improvements damaged by such taking, in case of damage or destruction from a peril insured agains; the proceeds of such improvements within a reasonable time, unless purchaser elects that said proceeds shall be evoided to the restoration on the purchase price herein.

(5) The seller has delivered, or agrees to deliver within 15 days of the date of closing, a purchaser's policy of title insurance in

perchase price Ferein.

(3) The seller has delivered, or agrees to deliver within 15 days of the date of closing, a purchaser's policy of title insurance in standard form, or a commitment therefor, issued by Powers National This insurance Company, insuring the purchaser to the full amount of said purchase price against loss or damage by reason of defect in staler's title to said real estate as of the date of closing and containing no exceptions other than the following:

a. Printed general exceptions appearing in said policy form:

b. Liens or encumbrances which by the terms of this contract the purchaser is to assume, or as to which this conveyance haveunder is to be made subject; and

c. Any enisting contract or contracts under which soler is purchasing said real estate, and any mortgage or other obligation, which soler by this contract agrees to pay, none of which for the purpose of this paragraph (5) shall be deemed defects in seller's title.

(6) If seller's title to taid real vetate is subject to an enisting contract or contracts under which seller is purchasing said real estate, or any provinge or offer obligation, which seller is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser that have the right to make any payments accounty to remove the default, and any payments so meet shall be applied to the payments that falling due the seller under this contract.

(?) The seller agrees, name secriting full payment of the purchase price and interest is the manner above specified, to execute and deliver to purchaser a statutory warrenty deed to said real estate, excepting any part thereof hereafter taken for public use, free of abcumbrances except any that may attach after date of closing through any parson other than the seller, and subject to the following:

Any portion of the road providing access as shown on the recorded plat of Silver Star Acres, records of Skamania County.

(8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said real estate on date of closing and to retain possession so long as purchaser is not in default hereunder. The purchaser covenants to keep the buildings and other improvements on said real estate in good repair and not to permit waste and not to tree or permit the use of, the real estate for any illegal purpose. The purchaser covenants to pay all service, installation or construction charges for water, sever, electricity, garbage or other utility services furnished to said real estate after the date purchaser is entitled to possession.

(9) In case the purchaser falls to make any payment herein provided or to maintain insurance, as herein required, the seller may make such payment or effect such insurance, and any amounts so paid by the seller, together with interest at the rate of 10% per annum thereon from date of payment until repaid, shall be repayable by purchaser on seller's demand, all without prejudice to any other right the seller night have by reason of such dufault.

(10) Time is of the essence of this contract, and it is agreed that in case the purchaser shall fail to comply with or perform any condition or agreement hereof or to make any payment required hereunder promptly at the thine and in the manner increin required, the seller may elect to declare all the purchaser's rights hereunder terminated, and upon his doing so, all payments made by the purchaser bereinder and all improvements placed upon the real estate; shall be forfeited to the seller as liquidated damages, and the seller shall have right to re-enter and take puscession of the real estate; and no waiver by the seller of any default on the part of the purchaser shall be construed as a waiver of any subsequent default.

Service upon purchaser of all demands, notices or other payers with respect to forfeiture and termination of purchaser's rights may be made by United States Mail, postage pre-paid, return receipt requested, directed to the purchaser at his address last known to the seller.

(11) Upon seller's election to bring suit to enforce any covenant of this contract, including suit to collect any payment required hereunder, the purchaser agrees— yay a reasonable sum as storney's fees and all costs and expenses in connection with such suit, which sums shall be included in any judgment or decree entered in such suit.

If the seller shall bring suit to procure an adjud'action of the termination of the purchaser's rights becauder, and judement is so entered, the purchaser agrees to pay a masonable sum as attorney's fees and all costs and expenses in connection with such suit, and also lie reasonable cost of searching records to determine the condition of title at the date such suit is commenced, which sums shall be included in any judgment or decree entered in such suit.
