## DEDICATION DEED

GRANTOR(S) Vennie Davis, a widow

for and in consideration of the sum of Ten Dollars and other valuable considerations (\$ 10.00 ) Dollars, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to SKAMANIA County, State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of SKAMANIA, State of Washington:

A right of way for the road known and designated as Bushlach Road and located in the South half of the South half of Section 4, Township 1 North, Range 5 East W.M. in Skamania County, Washington, more particularly described as follows:

A forty foot strip being parallel to and 20 feet distant from the platted centerline on file in the Office of Engineer for Skamania County, said survey centerline being dated 1941. This centerline beginning at mile post 12.35 left on State Route 140; thence northwest 21 feet; thence S 56° 53' W 203.3 feet; thence on a 818.60 foot radius curve to the right through an angle of 7° 12' for a distant of 102.85 feet; thence S 64° 05' W 13.92 feet; thence on a 229.20 foot radius curve to the right through an angle of 23° 31' for a distant of 114.13 feet; thence N 87° 23' W 202.92 feet; thence on a 382.00 foot radius curve to the right through an angle of 19° 29' for a distant of 129.89 feet; thence N 67° 54' W 65.01 feet; thence on a 143.25 foot radius curve to the left through an angle of 37° 20' for a distant of 93.36 feet; thence S 74° 46' W 100 feet more or less to the West line of the southwest one quarter of the southeast one quarter of said Section 4 of Township 1 North, Range 5 E.W.M.

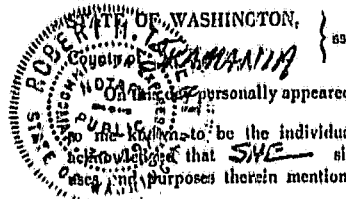
