GRANTOR(S) Stephanie Magruder, surviving spousefor and in consideration of the sum of Two Dollars and other valuable considerations(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general publicwelfare, do by these presents grant, convey and dedicate to SKAMANIA County,

State of Washington, for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of SKAMANIA State of Washington:

A right of way for the County Road known and designated as Brooks Road (County Road No. 20510) located on a parcel of land located in the Southwest quarter of the Northwest quarter of the Southwest quarter of Section 17, Township 3 North, Range 8 East, W.M. in Skamania County, Washington and described in deed No. 41-465, McDANNALD to MAGRUDER, on record in the Office of the Auditor, Skamania County; a right of way more particularly described as follows:

Beginning at the Southwest corner of the Southwest quarter of the Northwest quarter of the Southwest quarter of Section 17, Township 3 North, Range 8 East, W.M.; thence North along the West line 50 feet to a point being the center of a 50 foot radius cul-de-sac. Said right of way including all land within the above 50 foot radius line and East of the West line of said Southwest quarter of the Northwest quarter of Southwest quarter of Section 17, Township 3 North, Range 8 East, W.M.
