TREMMEL, husband and wife, the following described real estate, situated in the County of Skamania, State of Washington:

A tract of land located in the Joseph Robbins D. L. C. in .ection 27, Township 3 North, Range 8 E. W. M., described as follows:

Beginning at the northeast corner of the said Section 27; thence south O1° 58' 25" east along the section line 660 feet; thence south O1° 58' 25" east 660 feet, more or less, to the north line of the said Robbins D. L. C.; thence west along said north line 323.96 feet to the true point of beginning; thence west along said D. L. C. line 609.54 feet to a point 1,320 feet east of the northwest corner of the said D. L.
