A right of way as required for the County Road known and designated Lakeview Road (County Road No. 3001) located in Government Lot 3 and Government Lot 4 of Section 2, Township 3 North, Range 10 E.W.M. in Skamania County, Washington, more particularly described as follows:

Parcel ACENTERLINE DESCRIPTION

Beginning at a point 990 feet East of the southwest corner of the northwest one quarter of the northwest one quarter of Section 2, Township 3 North, Range 10 E.W.M., said point lying on the South line of Government Lot No. 4. Thence North 30 feet to centerline of Lakeview Road, said point on centerline lying on West line of Grantors property; thence East parallel to and 30 feet distance from South line of Government Lot 4, 330 feet more or less to intersect the East line of Government Lot 4 which is also the West line of Government Lot No. 3; thence East parallel and 30 feet distance from the South line of Government Lot No. 3 19.80 feet to the P.C. of a 674.1 foot radius curve to the left; thence along curve 68.63 feet; thence N 83° 30' E 232.99 feet to East line of Grantors property.

RIGHT OF WAY DESCRIPTION

A strip of land 60 feet in width lying 30 feet on the right and 30 feet on the left and parallel with and contiguous to the above described centerline. Said right of way containing 0.90 acres more or less.

Parcel BCENTERLINE DESCRIPTION

Beginning at a point on centerline of Lakeview Road, said point lying S 27° 52' W 255.24 feet from the North one quarter corner of Section 2, Township 3 North, Range 10 E.W.M. Thence North 28° 12' E 250 feet more or less to intersect the North line of Section 2, Township 3 North, Range 10 E.W.M.

RIGHT OF WAY DESCRIPTION

A strip of land 60 feet in width lying 30 feet on right and 30 feet on the left and parallel with and contiguous to the above described centerline. Said right of way containing 0.34 acres more or less.

Total right of way for both parcel "A" and parcel "B" is 1.24 acres more or less.

TO HAVE AND TO HOLD the said described premises unto the said SKAMANIA

County and its successor or successors for the use of the public forever.
