TO THE HONORABLE
THE UNITED STATES DISTRICT COURT:

WHEREAS, on November 18, 1975, a proceeding was instituted by the
filing of a complaint in this honorable court in the name of the United
States of America for the acquisition of certain interests in land situated
in the County of Clallam, State of Washington; and

WHEREAS, on November 18, 1975, a declaration of taking including
all of the land described in the complaint was duly filed in said proceeding
and

WHEREAS, it is necessary to amend said declaration of taking to
include an additional leasehold interest on Tract 2544 and to deposit
additional funds in the amount of \$4,940.00 as estimated compensation for
said Tract 2544.

NOW, THEREFORE, I, the undersigned, *Walter S. Schaffer*,
Secretary of the Army, pursuant to the powers and authorities recited in
the complaint and declaration of taking filed in the above entitled proceeding,
do hereby amend said declaration of taking as follows:

Substitute "Seventy Seven thousand Nine Hundred Fifteen and No/100
dollars (\$77,915.00)" in the Line Nos. 28 and 29 of the first page of the
said declaration of taking reading "Seventy Two Thousand Nine Hundred
Seventy Five and No/100 Dollars (\$72,975.00)".

Substitute Schedule "B" attached hereto and made a part hereof
in Lieu of Schedule "B" attached to and made a part of the declaration of



2 The sum of \$72,975.00 has been deposited into the registry of the
3 court as the estimated just compensation for the acquisition of the land
4 included in the above mentioned declaration of taking. The sum of
5 \$77,915.00 is now estimated by me to be just compensation for the acquisition
6 of the land. Therefore, I cause to be deposited herewith in the registry
7 of this Honorable Court the additional sum of \$4,940.00 for the use and
8 benefit of the persons entitled thereto. I am of the opinion that the
9 ultimate award for said land probably will be within any limits prescribed
10 by law on the price to be paid therefor.

11 It is intended by this amendment that the aforesaid declaration
12 of taking is not changed, and is not intended to be changed, in any respect
13 except as hereinabove expressly set forth.

14 IN WITNESS WHEREOF, the United States of America, by its Secretary
15 of the Army, therunto authorized, has caused this amendment to be signed
16 in its name by said *Martin R. Hoffman*, Secretary of the Army,
17 this 23rd day of April A.D. 1976, in the City of Washington,
18 District of Columbia.
