REAL ESTATE CONTRACT

THIS CONTRACT, made and entered into this 16th day of August, 1976.

WITNESSETH: That the seller agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in Skamania County, State of Washington.

The terms and conditions of this contract are as follows: The persons price is SEVENTY-SIX THOUSAND FIVE HUNDRED and NO/100 - (5 76,500.00) Dollars, of which THIRTY-FIVE THOUSAND and NO/100 - (5 35,000.00) Dollars have tera paid, the receipt whereof is hereby acknowledged, and the balance of said purchase price shall be paid as follows:

The purchasers agree to pay the balance of the purchase price in the sum of Forty-One Thousand Five Hundred and No/100 (\$41,500.00) bollars in monthly installments of Three Hundred Fifty and No/100 (\$350.00) Bollars, or more, commencing thirty (30) days after the delivery of possession and on the same day of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The said monthly installments shall include interest at the rate of eight per-cent (8%) per annum computed upon the monthly balances of the unpaid purchase price, and shall be applied first to interest and then to principal. The purchasers reserve the right at any time they are not in default under the terms and conditions of this contract to pay without penalty any part or all of the unpaid purchase price, plus interest, then due.

Sellers agree to deliver possession of said premises to the purchasers within 120 days from and after the date of recording of this contract, or at seller's option prior to the expiration of said 120 day period.
