


WARRANTY DEED

The Grantor, CROWN ZELLERBACH CORPORATION, a Nevada corporation, in consideration of One Dollar (\$1.00) and other good and valuable consideration, to fit part, the receipt of which is hereby acknowledged, conveys and warrants to SKAMANIA COUNTY, a municipality of the State of Washington, the following described real property situated in the County of Skamania, State of Washington, to-wit:

All that portion of the E $\frac{1}{2}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 25, T2N, R7 $\frac{1}{2}$ E, W.M., contained within a strip of land being East of the existing county "Loop Road" right of way and a line 50 feet to the east of the following described reallocated road centerline, excepting such width shall be 30 feet to east from said centerline from ES 273+00.00 to ES 276+00.00, to-wit:

Commencing at a point known as Engineers Station (ES) 263+00.00 in the E $\frac{1}{2}$ NW $\frac{1}{4}$ of said section, thence S 3°21'25" W to a PC at ES 264+95.49 on a 550 foot radius 38°41'45" curve to the left; thence an arc distance of 371.45 feet on said curve to a PT at ES 266+66.20; thence S 27°15'40" E to a PC at ES 269+22.86; thence on the arc of a 400 foot radius 34°7'35" curve to the right an arc distance of 238.25 feet to a PT at ES 271.59.95; thence S 1°18'44" E to a PC at ES 273+58.21; thence on the arc of a 1000 foot radius 6°10'49" curve to the left an arc distance of 107.87 feet to PT at ES 274+64.53; thence S 7°23'34" E to ES 276+00.00, all in Skamania County, State of Washington.
