



## WARRANTY DEED

The Grantor, LEONARD M. BLACKLEDGE, surviving spouse of Betty May Blackledge, deceased, for and in consideration of Ten Dollars and other Valuable Considerations in hand puld, convey and warrant to GLENN RICHIE, a single man, the following described weal estate, situated in the County of Skamania, State of Washington:

The Northeast Quarter of the Southeast Quarter of the Northwest Quarter (NE's SE's NW's) EXCEPT the north 80 feet thereof; the Southeast Quarter of the Southeast Quarter of the Northwest Quarter (SEE SEE NWE) EXCEPT the south 320 feet of the west 340 feet thereof; the Northeast Quarter of the Northeast Quarter of the Southwest Quarter (NEt NEt SWE) EXCEPT the north 340 feet of the west 340 feet thereof; the north 160 feet of the Southeast Quarter of the Northeast Quarter of the Southwest Quarter ( SEX NEX SUX); the east 220 feat of the north 160 feet of the Southwest Quarter of the Northcost Quarter of the Southwest Quarter (SW NE SWE); and the south 320 feer of the Northwest Quarter of the Northeast Quarter of the Southwest Quarter (NWA NEW SWW) EXCOURT the west 440 feet thereof; all in Section 35, Township 4 North, Range 7 F. RESERVING to the grantor, his heirs, and assigns an easement and right of way for an underground water pipeline one and one-fourth inches in elemeter as now constructed and installed in a northerly and southerly direction over and across the Northeast Quarter of the Southwest Quarter (NEE SWE) of Section 35, Township 4 North, Range 7 E. W. M.
