The perpetual right, power, privilege and easement permanently to overflow, flood and submerge the land described in Schedule "A" and to maintain mosquito control in connection with the operation and maintenance of the Borneville Lock and Dam project as authorized by the Act of Congress approved 20 August 1937, and the continuing right to clear and remove any brush, debris and natural obstructions which, in the opinion of the representative of the United States in charge of the Project, may be detrimental to the project, together with all right, title and interest and to the timber, structures and improvements situate on the ; grivided that no structures for human habitation shall be constructed or maintained on the land, that no other structures shall be constructed or maintained on the land except as may be approved in writing by the representative of the United States in will red of the project, and that no excavation shall be conducted my indfill placed on the land without such approval as to t/a location and method of excavation and/or placement of landfill; the above estate is taken subject to existing easements for public rough and highways, public utilities, railroads and pipelines; legaring, however, to the landowners, their heirs and assigns, all such rights and privileges as may be used and enjoyed without interfaring with the use of the project for the purposes authorized by Congress or abridging the rights and easement hereby acquired; prowilled further that any use of the land shall be subject to Federal will state lave with respect to pollution.
