RESTRICTIVE COVENANTS

H. ROBERT COLE and HELEN R. COLE, husband and wife, and JU/NITA R. SYRES, a widow, the owners of the following described real property located in Ska-mania County, State of Washington:

Lots 1 to 17 inclusive of HIDEWAY II according to the official plat thereof on file and of record at page 4 of Book B of Plats, Records of Skemania County, Washington.

desiring to insure the use of the above described real property for attractive recreational and residential purposes, to prevent nuisances, to prevent impairment of the attractiveness of the property, to maintain the desired tone of the same as a recreational and residential district and thereby to secure to the future owners of each lot the full benefit and enjoyment of his residence with no greater restrictions upon the free and undisturbed use of his lot than is necessary to insure the same advantages to the other lot owners, do hereby impose upon the above described real property the following building restrictions and restrictive covenants.

- 1. All dwellings, trailers, mobile homes, permanent or temporary shall be of a type to harmonize with the area, and be kept in good repair.
- 2. All fences must be of a type to be harmonious with the area.
- No horse, cow, hog, goat, sheep or other similar animal, and no barnyard fowl of any kind shall be kept or maintained on any of the aforesaid lots or any portion thereof.
- 4. Said lots shall be maintained to preserve the natural beauty of the area. Garbage and trash shall be preperly contained and properly disposed of and not allowed to a commulate as to become a nuisance.
- No car or other vehicle shall be kept on said premises unless properly licensed.
- None of the aforesaid lots shall be used for any business or commercial purpose.
- 7. Each dwelling house constructed on any of the aforesaid lots shall be fully completed on the exterior portion thereof within two years from the commencement of construction.
- 8. Septic tanks will be constructed and installed on the aforesaid lots structly in compliance with the Skämania County ordinance and the rules and regulations of the State Department of Health.
- 9. All electric power distribution lines, telephone lines, television cables and plpelines for water and natural gas and other utilities shall be constructed underground and in accordance with plans submitted and approved by the platters.

RESTRICT: VE COVENANTS - Page Two.

Installation of electrical services shall be made strictly in accordance with plans approved by Public Utility District No. 1 of Skamania County, Washington.

All of the foregoing building restrictions and rentrictive coverants shall cease and terminate and thereafter be of no force or effect and shall not be enforceable, either at law or in equity on September 1, 2001. The building restrictions and restrictive covenants set forth above as hereby imposed shall be regarded at law and in equity as covenants running with the land; shall be tinding within the term thereof on all future owners of the aforeusid lots, their heirs, administrators, executors and assigns, and shall be imposed upon each lot for the benefit of each and every owner of the remaining lots. Any person hereafter accurring any right, title or interest in any of the aforesaid lots shall have the right to prevent any violation of the foregoing building, restrictions and restrictive covenants by the commencement of suit either at law or in equity and shall have the further right to damages and injunctive relief. Failure by any owner to enforce any of the aforesaid building restrictions or restrictive covenants shall not be deemed a waiver of the right to to do thereafter as to the same breech or violation or as to any other breech or violation.
