

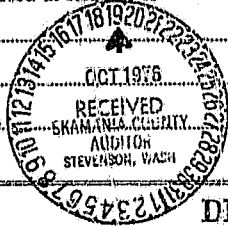

DEDICATION DEED

GRANTOR(S) Dora M. Crego, a widow

for and in consideration of the sum of Ten Dollars and other valuable considerations
 (\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public
 welfare, do by these presents grant, convey and dedicate to SKAMANIA County,
 State of Washington, for the use of the public as a county road and appurtenances the following de-
 scribed real property in the County of SKAMANIA, State of Washington:

A right of way for the County Road known and designated as the Cook-Underwood
 Road (County Road No. 93041) located in Skamania County, Washington in Section 19,
 Township 3 North, Range 10 East W.M. More particularly described as follows:

Beginning at the Southeast corner of said Section 19; thence S 89° 09' 0" W
 along the center line of the Cook-Underwood road 1,331.28 feet; thence N 65° 39'
 0" W 91.61 feet; thence N 43° 05' 0" W along the centerline of said road 769.78
 feet which point is the initial point of described tract; thence N 43° 05' 0" W
 83.55 feet to the P.C. of a 286.5 radius curve to the left; thence along said curve
 222.85 feet to the P.T.; thence N 87° 39' 0" W 171.41 feet; thence S 34° 01' 0" E
 49.67 feet to a point which is 40 feet distant from the above described centerline
 when measured perpendicular to the centerline; thence running parallel to and 40
 feet distant from centerline S 87° 39' 0" ; 141.96 feet to a point on a 246.5 foot
 radius curve to the right; thence along said curve 193.60 feet; thence S 43° 05' 0"
 E 108.94 feet to a point 40 feet distant from centerline; thence N 7° 19' 37" E 51.91
 feet to point of beginning.

 less existing rights of way for a net acreage
 of 0.11 acres more or less.
