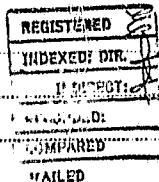
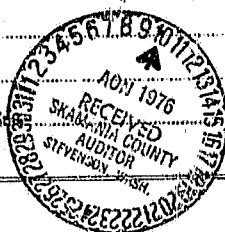

## DEDICATION DEED

GRANTOR(S) Dora M. Crego, a widow and William L. Crego, trustee,for and in consideration of the sum of Ten Dollars and other valuable considerations(\$ 10.00 ) Dollars, to us in hand paid, and in further consideration of the general publicwelfare, do by these presents grant, convey and dedicate to SKAMANIA County,

State of Washington, for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of SKAMANIA, State of Washington:

A right of way for the county road known and designated as the Cook-Underwood Road  
(County Road No. 93041) located in Skamania County, Washington, Section 19, Township  
3 North, Range 10 East W.M., more particularly as follows:

Beginning at the southeast corner of said Section 19; thence S 89° 09' 0" W along  
the centerline of the Cook-Underwood Road 1,289.72 feet to the P.C. of a 201.1 foot radius  
curve to the right; thence along said curve 167.65 feet to the P.T.; thence N 43° 05'  
0" W 189.91 feet; thence N 46° 53' 0" E 30 feet to a point on the northerly right of  
way line of the Cook-Underwood Road, said point being the P.C. of a 600 foot radius  
curve to the left, said P.C. being the initial point of described tract; thence along  
said curve 250 feet more or less to the east boundary of the grantors property; thence  
in a southerly direction along said property line 42 feet more or less to the northerly  
right of way line of the Cook-Underwood Road. Said right of way line being 30 feet from  
and parallel to centerline; thence westerly along said right of way line to initial point  
of tract.

Containing a total of 0.12 acres more or less.
