


DEDICATION DEED

GRANTOR(S) Bruce Konell, and Bethewel Handryx, as a separate estate,

for and in consideration of the sum of Ten dollars and other valuable considerations
(\$10.00) Dollars, to us in hand paid, and in further consideration of the general public
welfare, do by these presents grant, convey and dedicate to Skamania County,
State of Washington, for the use of the public as a county road and appurtenances the following de-
scribed real property in the County of Skamania State of Washington:

A right of way as required for the County Road known and designated Leah's
Road (County Road No. 32510) located in Government Lot No. 4, Section 2, Township
3 North, Range 10 East W.M. in Skamania County, Washington, more particularly de-
scribed as follows:

A strip of land sixty (60) feet in width lying 30 feet each side of the center
line of the existing road, which said existing centerline being approximately
30 feet north and parallel with the south line of Government Lot No. 4,
said point lying 660 feet easterly from the southwest corner of said Govern-
ment Lot No. 4; thence running easterly 30 feet along said south line of
Government Lot No. 4 to the easterly boundary of the grantor's real property as
described in Real Estate Contract dated March 23, 1973, and recorded at Page 1343
176, Book of Deeds, Records of Skamania County.
