DEDICATION DEED

GRANTOR(S) George D. DeGroote and Gloria Z. DeGroote, husband and wifefor and in consideration of the sum of Ten Dollars and other valuable considerations(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general publicwelfare, do by these presents grant, convey and dedicate to SKAMANIA County,

State of Washington, for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of SKAMANIA State of Washington:

A right of way as required for the Skamania County Road known and designated Eymann Cemetery Road, County Road Number 20500, located in the Southeast quarter of the Southwest quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 17, Township 3 North, Range 8 East W.M.

MORE PARTICULARLY DESCRIBED: Beginning at the County Monument marking the South one quarter corner of Section 17, Township 3 North, Range 8 East W.M.; thence N 88° 20' 37" W along the South line of said Section 17 684.13 feet to the Southwest corner of the subdivision known as Carson Valley II being the initial point of the right of way herein described; thence N 88° 20' 37" W 611.16 feet to the Southwest corner of the Southeast quarter of the Southwest quarter (SE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section 17; thence N 0° 05' 17" E 19.00 feet; thence S 89° 22' 32" E 610.91 feet to the West line of Carson Valley II Subdivision; Thence S 0° 00' 04" E 30.01 feet along said West line to initial point.
