COMMUNITY PROPERTY AGREEMENT

This Community Property Agreement entered into this date by and between LAWRENCE E. SMXTH and KATHRYN L. SMITH, husband and wife, both of Carson, County of Skamania, State of Washington:

WITNESSETH:

WHEREAS, the parties hereto are the owners of certain real and personal property situate in the State of Washington; and

We hareby mutually agree that all of the property which shall hermafter be acquired by either of us, whether separately, jointly or otherwise, and of whatsoever nature and wheresoever situate, shall be and it is hereby declared to be community property, and each of the parties does hereby convey and transfer to the other and to the community all such property

IT IS FURTHER AGREED that the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once, in the event of the death of LAWRENCE E. SMITH while the said KATHRYN L. SMITH survives, be vested in KATHRYN L. SMITH absolutely and in fee simple as her sole and separate property; and in the event of the death of the said KATHRYN L. SMITH while the said LAWRENCE E. SMITH survives, then the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once vest in the said LAWRENCE E. SMITH absolutely and in fee simple as his sole and separate property.
