heraby convey and warrant to the STATE OF WASHINGTON, the following described real estate situated in Skamania County, in the State of Washington, to the same extent and purpose as if the rights herein granted had been acquired under Eminent Domain statute of the State of Washington:

A tract of land located in the Chas. M. Findley Donation Land Claim in Section 31, Township 3 North, Range 9 East of the Willamette Meridian, described as follows:

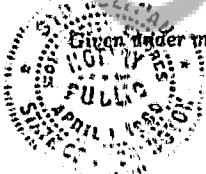
Beginning at the intersection of the northerly right of way line of Primary State Highway No. 8 with the center of Collins Creek; thence following the northerly right of way line of said highway south 80° west 280 feet, more or less, to the easterly line of a tract of land 1.12 acres in area conveyed to the State of Washington by deed dated February 14, 1950, and recorded March 15, 1950, at page 8 of Book 33 of Deeds, records of Skamania County, Washington; thence north 02° 30' west 755 feet; thence north 80° east 250 feet, more or less, to the center of Collins Creek; thence following the center of Collins Creek southerly to the point of beginning.

The undersigned grantors agree to surrender possession of the lands herein conveyed on November 28 1976.

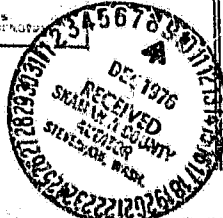
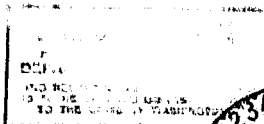
