## COMMUNITY PROPERTY AGREEMENT

This Community Property Agreement entered into this dake by and between JOHN G. ALLINGER and DOROTHY E. ALLINGER, husband and wife, both of Vancouver, County of Clark, State of Wishington:

HITNESSETH:

WHEREAS, the parties hereto are the owners of certain real and personal property situate in the State of Washington; and

We hereby mutually agree that all of the property which small hereafter be acquired by either of us, whather separately, jointly or otherwise, and of whatsoever nature and whereacever situate, small be and it is hereby declared to be community property, and each of the parties does hereby convey and transfer to the other and to the community all such property hereafter acquired by either of them, soon though the same be acquired in his or her separate estate, and

ALLINGER survives, then the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once vest in the said JOHN G. ALLINGER absolutely and in fee simple as his sole and separate property.
