COMMUNITY PROPERTY AGREEMENT

PALMER survives, then the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once vest in the said ALVA M. PALMER absolutely and in fee simple as his sole and separate property.
