REAL ESTATE CONTRACT

THIS CONTRACT, made and entered into this 15th day of December, 1976

between ROSIE M. MEYERS, who acquired title as Rosie M. Austin,

hereinafter called the "sellet," and BEN D. ROTH, a single man,

WITNESSETH: That the relier agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in SKAMANIA County, State of Washington:

The terms and conditions of this contract are as follows: The purchase price is Sixteen Thousand Five Hundred and no/100 ----- (\$ 1.6,500.00) Dollars, of which Eight Thousand Five Hundred and no/100----(\$ 8,500.00 been paid, the receipt whereof is hereby acknowledged, and the balance of said purchase price shall be paid as follows:

The purchaser agrees to pay the balance of the purchase price in the sum of Eight Thousand and No/100 (\$8,000.00) Dollars in monthly installments of One Hundred Sixty-Six and 07/100 (\$166.07) Dollars, or more, commencing on the 15th day of January, 1977, and on the 15th day of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The said monthly installments shall include interest at the rate of nine per-cent (9%) per annum computed upon the monthly balances of the unpaid purchase price, and shall be applied first to interest and then to principal. The purchaser reserves the right at any time he is not in default under the terms and conditions of this contract to pay without penalty any part or all of the unpaid purchase price, plus interest, then due.

As elerred to in this contract, "date of closing" shall be __December 15, 1976

() The purchaser assumes and agrees to pay before delinquency all taxes and assessments that may as between grantor and grantee hereaft r become a lieu on said real estate; and if by the terms of this contract the purchaser has assumed payment of any mortigate, contract or other encumbrance, or has assumed payment of or agreed to purchase subject to, any taxes or assessments now a lieu on said real estate. The purchaser agrees to pay the same before delinquency.

(2) The purchaser agrees, until the purchase price is fully paid, to keep the buildings now and hereafter placed on said real estate insured to the actual cash value thereof against loss or damage by both fire and windstorm in a company acceptable to the seller and for the seller's benefix, as his interest may appear, are to pay all premiums therefor and to deliver all policies and renewals thereof to the seller.

(1) The purchaser agrees that full inspection of said real estate has been made and that neither the seller nor his assigns shall be held to any covenant especting the condition of any improvements thereon nor shall the purchaser or seller or the assigns of either he held to any covenant especially and attached to and made a part of this contract.

(8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said real estate on date of closing and to retain possession so long as purchaser is not in default hereunder. The purchaser covenants to pay all service, installation or construction charges for water, sewer, electricity, garbage or other utility services furnished to said real estate for any file-ral purpose.
