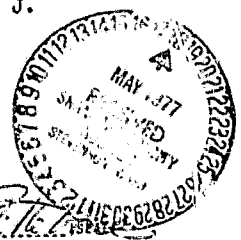
for and in consideration of ten and no/100 (\$10.00) dollars and other good and valuable consideration,
