TRANSACTION EXCISE TAX

(1) The purchaser assumes and agrees to pay before delinquency all taxes and assessments that may as between grantor and arantee hereafter become a lien on soid real estate; and if by the terms of this contract the purchaser has assumed payment of any mortgage, deed of trust, contract or other encumbrance, or has assumed payment of or agreed to purchase subject to any laxas or assessments now a lien on said real estate, the purchaser agrees to pay the same before delinquency.

(2) The purchaser agrees, until the purchase price is fully paid, to keep the buildings now and hereafter placed on add seater insured to the actual cush value thereof against loss or damage by both fire and windstorm in a company acceptable to the seller and for the seller's benefit, as his interest may appear, and to pay all premiums therefor and to deliver all policies and renewals thereof to the seller.

(2) The purchaser agrees that full inspection of said real actate has been made and that neither the selfer ner his assignmental be held to any covenant respecting the condition of any improvements thereon nor shall the purchaser or seller or the dassigns of either be held to any covenant or agreement for alterations, improvements or repairs unless the covenant or agreement relied on is contract.

(4) The purchaser assumes all houseds of damage to or destruction of any Improvements now on said real estate or hereafter placed thereon, and of the taking of said real estate or any part thereof for public use; and agrees that no such damage,
destruction or taking shall constitute a failure of consideration. In case any part of said real estate is taken-for public use,
the portion of the condemnation oward remaining after payment of reasonable, expenses of procuring the same shall be paid to
the seller and applied 1.3 payment on the purchase price herein unless the seller elects to allow the purchaser to apply all or
a portion of such condemnation oward to the rebuilding of restoration of any involvements damaged by such taking, in case of
dynage or destruction from a peril insured against, the proceeds of such insurance remaining after payment of the reasonable
stakense of procuring the same shall be devoted to the restoration or, rebuiling of such improvements within a reasonable
time, unless purchaser elects that said proceeds shall be paid to the styler for application on the purchase price herein.

(6) The sailer has defined as a proceeding and the processing the same shall be devoted to the styler for application on the purchase price herein.

a. Printed general exceptions appearing in said policy form;

b. Liens or ancumbraneas which by the terms of this contract the purchaser is to assume, or as to which the conveyance hereunder is to be made subject and

c. Any existing contract or contracts under which seller is purchasing said real estate, and any mortgage or other abliquation, which seller by this contract agrees to pay, note of which for the purpose of this paragraph (5) shall be deemed defacts in seller's sitle.

(7) The seller agrees, upon receiving full payment of the purchase exice and interest in the manner above specified, to execute and deliver to purchaser a statutory warranty deed to said read entate, excepting any part thereof hereafter taken for public user free of encumbrance; except any that may attach after date of clusting through any person other than the seller, and subject to the following:

Easements, rights of way, and water rights of record, and contract for electrical service with Public Utility District No. 1 of Klickitat County.

(8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of soid tool estate on date of closing and to retain possession so long as purchaser is not in default hereunder. The purchaser covenants to keep the buildings and other improvements on said real estate in good repair and not to permit waste and not to use, or permit the use of, the real estate for any lilegal purpose. The purchaser covenants to pay a service, installation or construction charges for water, sever, electri-ity, garbage or other utility services furnished to said real estate after the date purchaser is entitled to accessesion.

(9) In case the purchaser fails to make any payment herein provided or to maintain insurance, as herein required, the seller may make such payment is affect such insurance, and any a nounts so paid by the seller, together with interest at the rate of 10% per "nount therest is from date of payment until repaid, shall be repayable by purchaser on seller's demand, all without prejudic is any other right the seller might have by reason of such default.

(10) Time is to be essence of this contract, and it is agreed that in case the purchaser shall fail to comply with or perform any condition or freement hereof or to make any payment required hereunder promptly at the time and in the manner herein required, the seller may elect to declare all the purchaser's rights liceunder terminated, and upon his doing so, all payments made by the purchaser hereunder and all improvements placed upon the real estate shall be forfeited to the seller as liquidated in the part of the purchaser shall have right to re-enter and take possession of the real estate; and no valver by the seller of any default on the part of the purchaser shall be construed as a waiver of any subsequent default.

Service upon purchaser of all demands, notices or other papers with respect to forfeiture and termination of purchaser's rights may be made by United States Mail, postage pre-paid, return recitipt requested, directed to the purchaser a his address lost known to the seller.

If the seller shall bring suit to procure an adjudication of the termination of the purchaser's rights hereunder, and judgment is so entered, the purchaser agrees to pay a reasonable sum as attorney's fees and all costs and expanses in connection with such suit, and also the reasonable cost of searching records to determine the condition of title at the date such suit is commenced, which sums shall be included in any judgment or decree entered in such suit.
