welfare, do by these presents grant, convey and dedicate to Skamania County,

State of Washington, for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of Skamania, State of Washington:

A right of way for the County Road known and designated Jessup Road (County Road No. 30850) located in the Northeast quarter of the Southeast quarter of the Southeast quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 10, Township 3 North, Range 9 East W.M. in Skamania County, Washington.

MORE PARTICULARLY:

All that portion of the Northeast quarter of the Southeast quarter of the Southeast quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 10, Township 3 North, Range 9 East W.M. lying northerly and northwesterly of the Jessup Road as existing in June, 1977 and lying southerly and northeasterly of the following described line:

Beginning at the iron pipe marking the corner common to Sections 10, 11, 14, and 15, Township 3 North, Range 9 East W.M.; thence N 1° 59' 23" E 798.45 feet along the east line of Section 10; thence West 90° 00' 26.88 feet to the initial point of the line hereby described; thence S 33° 50' 25" W 42.44 feet; thence S 55° 10' 13" W 43.68 feet; thence S 87° 08' 33" W 47.80 feet; thence N 75° 39' 33" W 70.02 feet.
