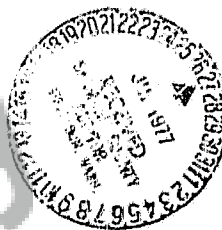

EXHIBIT "A"

Beginning at a point in the center of Wind River 360 feet North of the northerly line of Blaisdell tract in Section 23 Township 4 North of Range 7 East of Willamette Meridian as shown by the official plat thereof recorded at page 83 Book A of Plats records of Skamania County, Washington; thence in an easterly direction in a straight line to a point on the southerly line of the old County Road which is 400 feet north of the northerly line of said Blaisdell tract; thence along the southerly and westerly line of said old road in a northerly direction to the north line of the SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of section 23 Township 4 North Range 7 East of Willamette Meridian; thence westerly along the said north line of SW $\frac{1}{4}$ of SE $\frac{1}{4}$ to the center line of Wind River; thence southerly following the center line of Wind River to the point of beginning.

Excepting that portion conveyed to George A. Gross and Shirley Gross by deed dated January 5, 1939, recorded January 5, 1939 at page 292 Volume 27 of Deed records of Skamania County, Washington.
