A portion of the Southeast quarter of Section 17, Township 1 North, Range 5 East of the Willamette Meridian, Skamania County, Washington, described as follows:

BEGINNING at a point that is the PC of a road centurline, which point is South 0°08'39" East, 3041.30 feet (Washington Coord. System, South Zone) from an iron pipe at the Northeast corner of said Section 17;

THENCE South 77°56'00" West along said centerline, 1045.34 feet;

THENCE along the arc of a 50 foot radius curve to the left for an arc distance of 70.95 feet;

THENCE South 03022'00" Fast, 297.21 feet;

THENCE along the arc of a 200 foot radius curve to the left for an arc distance of 130.38 feet;

THENCE South 40043'00" East, 246 feet, more or less, to the North right-of-way line of State Highway 14;

THENCE following said right-of-way line, Northeasterly to a point which bears South 5000'00" East from the POINT OF BEGINNING;

THENCE North $5^{\circ}00'00''$ West, 333.84 feet, more or less, to the POINT OF BEGINNING.
