REAL ESTATE CONTRACT

WITNESSETH: That the sellers agree to sell to the purchasers and the purchasers agree to purchase from the sellers the following described real estate, with the appurtenances, situated in Skamania County, State of Washington:

Lots 1 and 2 and the North half of Lot 6, Block One (1) of the ESTABROOK ADDITION to the Town of Carson, Washington, as zhown of record in the office of the Skamania County Auditor.

The terms and conditions of this contract are as follows:
The purchase price is FIFTEEN THOUSAND, FIVE HUNDRED and no/100 Dollars (\$15,500.00), of which TEN THOUSAND DOLLARS (\$10,000.00) has
been paid, the receipt of which is hereby acknowledged, and the
balance of said purchase price shall be paid as follows:

The sum of \$79.16 shall be paid on or before the 14 day of Cobic. 1977, and a like payment made on the 14t day of each and every month thereafter until both principal and interest have been paid in full. The unpaid principal balance is to bear interest at the rate of 8 1/2% per annum, and from each payment shall first be deducted interest to date and the balance shall be applied on the principal.

Permission is granted to purchasers to make larger payments at any time, or to pay the contract in full, without penalty, and interest shall immediately cease on all payments so made.

All payments to be made hereunder shall be made at ________, or at such other place as the sellers may direct in writing.

As referred to in this contract, "date of closing" shall be Object 1 of , 1977.

(1) The purchasers assume and agree to pay before delinguency all taxes and assessments that may as between grantor and grantees hereafter become a lien on said real estate.

- (2) The purchasers agree, until the purchase price is fully paid, to keep the buildings now and hereafter placed on said real estate insured to the actual cash value thereof against loss or damage by both fire and windstorm in a company acceptable to the sellers and for the sellers' benefit, as their interests may appear, and to pay all premiums therefor and to deliver all policies and renewals thereof to the sellers.
- (3) The purchasers agree that full inspection of said real estate has been made and that neither the sellers nor their assigns shall be held to any covenant respecting the condition of any improvements thereon nor shall the purchasers or sellers or the assigns of either be held to any covenant or agreement for alterations, improvements or repairs unless the covenant or agreement relied on is contained herein or is in writing and attached to and made a part of this contract.
- (4) The purchasers assume all hazards of damage to or destruction of any improvements now on said real estate or hereafter placed thereon, and of the taking of said real estate or any part thereof for public use; and agrees that no such damage, destruction or taking shall constitute a failure of consideration. In case any part of said real estate is taken for public use, the portion of the condemnation award remaining after payment of reasonable expenses of procuring the same shall be paid to the sellers and applied as payment on the purchase price herein unless the sellers elect to allow the purchasers to apply a-1 or a portion of such condemnation award to the rebuilding or restoration of any improvements damaged by such taking. In case of damage or destruction from a peril insured again, the proceeds of such insurance remaining after payment of the reasonable expense or procuring the same shall be devoted to the restoration or rebuilding of such improvements within a reasonable time, unless purchasers elect that said proceeds shall be paid to the sellers for application on the purchase price herein.
 - (5) The sellers have delivered, or agree to deliver within 90 days of the date of closing, a purchaser's policy of title

- the purchasers shall be entitled to possession of said real extraction on date of closing and to retain possession so long as purchasers are not in default hereunder. - (8) In case the purchasers fail to make any payment herein provided or to maintain insurance, as herein required, the sellers may make such payment or effect such insurance, and any amounts
 so paid by the sellers, together with interest at the rate of 100
 per annum thereon from date of payment until repaid, shall be repayable by purchasers on sellers' demand, all without prejudice to
 any other right the sellers might have by reason of such default.
- agreed that in case the purchasers shall fail to comply with or perform any condition or agreement hereof or to make any payment required hereunder promptly at the time and in the manner herein required, the sellers may elect to declare all the purchasers rights hereunder terminated, and upon their doing so, all payment

made by the purchasers hereunder and all improvements placed upon the real estate shall be forfeited to the sellers as liquidated damages, and the sellers shall have the right to re-enter and take possession of the real estate; and no waiver by the sellers of any default on the part of purchasers shall be construed as a waiver of any subsequent default.

Service upon purchasers of all demands, notices or other papers with respect to forfeiture and termination of purchasers' rights may be made by United States Mail, postage prepaid, return receipt requested, directed to the purchasers at their address last known to the sellers.
