

## REAL ESTATE CONTRACT

THIS CONTRACT, mode and entered into this day of setween RONALD SCOTT MALPAIT, as his separate property,

hereinefter colled the "seller," and ERIC P. BALHOLM and LINDA S. BALHOLM, husband and wife,

beceinafter called the "purchasor,"

WITNESSETH: That the seller agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in Skamania County, State of Washingtons

ATTACHED.



The balance of Eight Thousand Eight Hundred and no/100 (\$8,800.00) Dollars shall be paid as follows: In monthly installments of One Hundred and no/100 (\$100.00) Dollars beginning with the 1st day of October, 1977 and continuing monthly thereafter until the whole balance of the purchase price, both principal and interest, shall have been fully paid. The unpaid balance of the purchase price shall at all times bear interest at 8.5 per cent per annum, and from each payment shall first be deducted interest to date and the balance shall be applied on principal. Permission is especially granted to purchaser to make larger payments at any time, or to pay the contract in full, and interest shall immediately case on all payments so made.

#11 payments to be made hereunder shall be made at as at such other place as the seller may direct in writing.

As referred to in this contract, "date of clasing" shall be

- (1) The purchaser assumes and agrees to pay before deligoratery all taxes and sociosments that may as between granter and quantee hereafter become a lien to said real estate, and if by the terms of this contract the purchaser has assumed payment of any martigage, deed of trust, contract or other encumbrance, or has assumed a payment at or agreed to purchase subject to any laxes or assessments now a lien on said real estate, the purchaser agrees to pay the same before delinquency.
- (2) The purchaser agrees, until the purchase pice is fully perman agrees to private and weather placed or said red extent insured to the actual risk value thereof against less a damage by both fire and windstarr in a company accepts to the seller and for the seller's benefit, as his interest may appear, and to pay all premiums therefor and to deliver all policies and remands thereof to the seller.
- 13) The purchaser agrees that full inspection of sail real extate has been made and that neither the seller nor his assigns shall be hold to any coverant respecting the residition of any improvements thereon nor shall the purchaser or seller or the vasigns of either be held to any coverant or agreement for alterations, improvements or imports acless the coverant or agreement for alterations, improvements or imports acless the coverant or agreement relief on its contract.

(5) The seller has delivered, or agrees to deliver within 15 days of the date of closing, a purchaser's policy of title insurance in standard form, or a commissional therefor, issued by SAFECO Title insurance Company, insuring the purchaser to the full amount of said purchase price against loss or raimage by reason of defect in seller's title to cald real estate as of the date of closing and containing no exceptions other than the following.

- a. Printed general exceptions appearing in said paticy form,
- b. Liens it excumbrances which by the terms of this contract the purchaser is to assume, or as to which the conveyance hereunder is to be made subject, and
- A. Any existing contract or contracts under which seller is purchasing said real estate, and any mortgage or other obligations which sales by this contract agrees to pay, none of which for the purpose of this paragraph (5) shall be degree defects in seller's title.

(6) If seiler's title to said real estate it subject to an existing contract or contracts under which seller is purchasing said real estate, or any murtages, deed of trust or other obligation which seller is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser shall have the right to reake any payments necessary to remake the default, and any payments so made shall be applied to the payments text falling due the teller undir this contract.

(7) The seller agrees, upon rectiving full payment of the purchase price and inverest in the manner above specified, to execute and deliver to purchaser a statutory warronty <u>Fulfillment</u> deed to said real estate, excepting any part thereof hereafter taken for public use, free of encumbrances except any that may attach ofter date of classing through any person other than the seller, and nubject to the following:

(E) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said real estate an date of closing and to retain possession so long as purchaser is not in default hereunder. The purchaser covenants to keep the buildings and other improvements on said real estate in good repair and not to permit waste and not to use, or purmit the use of, the real estate for any illegal purpose. The purchaser covenants to may be service, installation or construction charges for water, sewer, electricity, garbage or other utility services furnished to said real estate after the date purchaser in anital to possession.

(9) In case the purchaser fails to make any payment herein provided or to maintain insurance, as herein required, the seller may make such payment or effect such insurance, and any amounts so paid by the seller tagether with interest at the rate of 10% per annum thereon from date of payment until repoid, shall be repayable by purchaser on seller's demand, all without prejudice to any other right the seller might have by reason of such default.

(10) Time is all the assence of this contract, and it is agreed that in case the purchaser shall fail to comply with or perform any condition or agreement hereof or to make any payment required heriunder promptly of the time and in the monner haroin requirind, the seller may elect to declare all the purchaser's rights here, inder terminated, and upon his doing so, all payments made by the purchaser hereinder and all improvements placed upon the real estate shall be forfested to the seller as liquidated damages, and the seller shall have right to re-enter and take possession of the real estate, and no waiver by the seller of any default on the part of the purchaser shall be construed as a waiver of any subsequent default.

Service upon purchaser of all demands, notices or other papers with respect to freturue and termination of purchaser stights may be made by United States Mail, postage pre-paid, return receipt requested, directed to the purchaser at his address lost known to the seller.

(11) Upon seller's election to bring suit to enforce any covenant of this contract, including suit to collect any payment required hereunder, the purchaser agrees to pay a reasonable sum as attorney's fires and all costs and expenses in connection with such suit, which sums that the included in any judgment or decree entered in such suit.

If the seller shall bring suit to procure an adjudication of the termination of the purchaser's rights hereunder, and judgment is see entered, the purchaser garges to pay a reasonable sum as attorney's fees and all costs and averages in connection.
