for and in consideration of the sum of Ten Dollars and other valuable considerations
(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public
 welfare, do by these presents grant, convey and dedicate to SKAMANIA County,
 State of Washington, for the use of the public as a county road and appurtenances the following de-
 scribed real property in the County of SKAMANIA, State of Washington:

A right of way for the County Road known and designated Old Detour Road (County
 Road No. 23310) located in the northwest quarter (NW $\frac{1}{4}$) of Section 17, Township 3 North,
 Range 8 East W.M.

MORE PARTICULARLY: A parcel of land in Lot 1 of Lethlean Short Plat No. 2,
 described as follows: Beginning at a point on the west line of Section 17, said point
 lying S 0° 57' 20" W 1321.80 feet from the northwest corner of Section 17; thence
 N 0° 57' 20" E 20.27 feet; thence easterly following an arc to the left 217.35 feet,
 said arc having a radius of 263.06 feet and whose long chord bears N 76° 52' 20" E
 211.22 feet; thence N 53° 12' E 5.21 feet; thence S 0° 57' 20" W 35.70 feet; thence
 westerly following an arc to the right 216.78 feet, said arc having a radius of 318.3
 feet and whose long chord bears S 80° 20' 30" W 212.61 feet to point of beginning.
